4. The Commission has initiated a proceeding to investigate a temporary local telephone number portability solution to implement competition in local exchange telephone markets.

5. Sprint is currently a provider of telecommunications services and a competitor in the Florida interexchange long distance market. Sprint is also a potential competitor in the local exchange telephone market. Numbering resources is at issue in this docket and any change from the current structure will effect new entrants in the local exchange market.

6. Sprint respectfully submits that any action taken by the Commission in this proceeding may have a direct and material effect upon the legal rights, duties, privileges, immunities or other legal interests of Sprint. Sprint has a substantial interest in a Commission determination with respect to these interests which are not otherwise represented in this proceeding.

7. Sprint respectfully requests that it be granted leave to intervene and participate as a party of record in the above-captioned proceeding and that Sprint be given the right to fully participate in any hearing, present testimony, conduct cross-examination and to file briefs.


