By Order No. PSC-93-0546-FOF-TA, issued on April 12, 1993, in Docket No. 930103-TA, Time Warner AxS of Florida, L.P. ("Time Warner" or "Company") was granted Florida Public Service Commission Alternative Access Vendor Certificate No. 3167 which authorized the Company to provide alternative access vendor ("AAV") services effective May 4, 1993.

Pursuant to Section 364.337(6)(b), Florida Statutes, as amended effective July 1, 1995,

Any certificated alternative access vendor as of the date this act becomes a law wishing to provide alternative local exchange telecommunications service in addition to the services authorized in its certificate may do so, effective January 1, 1996, upon furnishing written notice to the commission.

Time Warner hereby furnishes written notice that, effective January 1, 1996, it wishes to provide alternative local exchange telecommunications ("ALEC") services in addition to the services authorized in its AAV certificate.
