Dear Sir or Madam:

We represent Telcom Network, Inc. ("TNI"), a telecommunications company. Monica M. Barone, Esq., of the Florida Public Service Commission, Division of Legal Services, has made an oral and written request for a copy of a contract between TNI, on the one hand, and GE Capital Communication Services Corporation and New Enterprise Wholesale Services, Ltd., on the other hand. TNI has agreed to provide Ms. Barone with a copy of the contract subject to the Florida Public Service Commission maintaining the contract's confidentiality. Please accept this letter as TNI's Notice of Intent to Request Confidential Classification of the contract.

The entire contract, including all addendums and exhibits, is confidential pursuant to Sections 350.121 and 364.183, F.S. Specifically, the entire contract constitutes trade secrets (§ 364.183(3)(a), F.S.), information concerning contractual data, the disclosure of which would impair the efforts of TNI or its affiliates to contract for goods or services on favorable terms (§ 364.183(3)(d), F.S.), and/or information relating to competitive interests, the disclosure of which would impair the competitive business of TNI (§ 364.183(3)(e), F.S.).

I enclose a copy of the contract (attached as Exhibit "A") and a copy of Ms. Barone's written request (attached as Exhibit "B"). As stated above, TNI is providing the contract with the understanding that disclosure of the contract is exempt from the public access requirements of Section 119.07(1), F.S., and will


