MCI Metro Access Transmission Services, Inc. - Certificate No. 2986, Metropolitan Fiber Systems of Florida, Inc. - Certificate No. 3151, Digital Media Partners - Certificate No. 3135, Time Warner AxS of Florida, L. P. - Certificate No. 3167, Continental Fiber Technologies, Inc. - Certificate No. 2973, Intermedia Communications of Florida, Inc. - Certificate No. 2939, Avant-Garde Telecommunications of Florida, Inc. - Certificate No. 4025, and City of Lakeland - Certificate No. 3572.
