ORDER STAYING ACTION AND REFERRING TO THE
FLORIDA PUBLIC SERVICE COMMISSION

THIS CAUSE came before the Court upon (1) Transcall America,
Inc. ("Transcall") and Advanced Telecommunications Corp.'s ("ATC")
Motion to Refer and Stay, (2) the Florida Public Service
Commission's ("PSC") Motion in Support of Transcall America, Inc.'s
Motion to Refer and Stay and upon (3) Transcall and ATC's Motion

to Dismiss or, Alternatively, Strike, Stay, and Refer Fourth Amended Counterclaims and Third Party Claims to the Florida Public Service Commission and the Federal Communications Commission. Upon having heard argument of counsel on February 10, 1995 and upon consideration of the record before the Court, it is,

ORDERED AND ADJUDGED as follows:

1. Transcall and ATC's Motion to Refer and Stay and the PSC's Motion in Support of Transcall's Motion to Refer and Stay are hereby granted. This action is hereby stayed and Transcall's pending Complaint and Telecommunication Services, Inc.'s pending Answer, Affirmative Defenses, Counterclaims and Third Party Claims are hereby referred to the Florida Public Service Commission for review and appropriate proceedings based upon and within the PSC's exclusive jurisdiction as provided by Florida Statute Chapter 364. The stay shall remain in effect until conclusion of the PSC proceedings or further Order of this Court.

2. Transcall and ATC's Motion to Dismiss, or Alternatively Strike, Stay, and Refer Fourth Amended Counterclaims and Third Party Claims to the Florida Public Service Commission and the Federal Communications Commission is moot to the extent it raises issues relating to PSC jurisdiction. However, all other arguments raised by the Motion, and all arguments raised by Transcall and ATC's Motion to Strike Affirmative Defenses, remain pending subject to this stay. The parties are not required to file any further

pleadings or motions with this Court during the pendency of this stay.
