

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission has issued a Florida PSC Audit Request to BellSouth dated November 1, 1995. Staff requests, among other things, that BellSouth furnish the following information:

Request No. 3, Item No. 1 - Billings associated with recurring and non-recurring charges for various Florida customers.

Request No. 4, Item No. 2 - Copies of Special Assembly Contracts outside of the State of Florida account.

Request No. 4, Item No. 3 - Copies of audits performed on ESSX accounts.

2. The information requested includes customer specific information, confidential business information and internal audit reports which are clearly proprietary. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3), (3)(b), (3)(c) and (3)(e), Florida Statutes.




