Florida's Citizens ("Citizens"), by and through Jack Shreve, Public Counsel, file this response and opposition to the motion for reconsideration filed by Southern States Utilities, Inc. ("Southern States") on December 15, 1995.


1. Today marks exactly five months from the date that the Citizens served a request for production of documents on Southern States seeking to inspect and copy income tax returns of Minnesota Power & Light. Citizens still do not have copies of these documents, despite our right to obtain copies of these documents under the discovery rules adopted by the Florida Public Service Commission.

2. Citizens have not consented, and do not now consent, to the attempts of Southern States to unilaterally impose a prohibition on our right to obtain copies of these documents.

3. The Citizens request the Commission to take up this matter as quickly as possible and deny Southern States' motion for reconsideration.
