The reason for this Application is to make the Certificate consistent with PSC policy as espoused in Order No. PSC-94-0230-FOF-SU (Fountain Lakes Sewer Corporation) and Order No. PSC-93-0500-FOF-WU (Lehigh Utilities, Inc.). The purpose for the change as acknowledged in Order No. PSC-95-0578-FOF-Su was to protect the assets of the Applicant from claims against its parent corporation, and to simplify financial and accounting reporting. The fact that there is no change in ownership and control of the utility and its assets was recognized by the Commission in Order No. PSC-95-0578-FOF-SU.
