Issue #3: What is the total purchased gas adjustment true-up amount to be collected during the period of April 1996 through March 1997?

SJNG's Position: \$94,454 underrecovery.

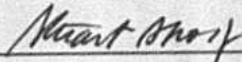

Issue #4: What is the appropriate levelized purchased gas adjustment recovery (cap) factor for the period April, 1996 through March, 1997?

SJNG's Position: 34.600 recovery (cap) factor

Issue #5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

SJNG's Position: The effective date for the new purchased gas adjustment charge should be April 1, 1996.
