The purpose of this letter is to inform you that Staff has reviewed your application in Docket No. 960028-SU. The application appears to be complete and Staff only has questions and some corrections that need to be made in regards to the sample tariff that was filed with the application. First, the following needs to be corrected in the sample tariff:

1. The Issuing Officer (Jack E. Mason) and Title (President) needs to be typed in on every page of the tariff as indicated in the bottom right corner of each sheet.
2. On each page that has a place for Effective Date and Type of Filing, the Effective Date should be left blank and the Type of Filing should be indicated as "Grandfather."
3. On Sheet No. 15.0, the initial connection fee and normal reconnection fee which is allowed is as follows:


