We have been gravely affected by Hurricane Opal. The storm surge damaged over two hundred of the mobile homes in the park served by the utility. The insurance company has totaled many of those homes and the residents have moved. The lots are now vacant, and no base facility charge or monthly meter fee is being collected.
