- 13.7.2 Description (Con't)
 - F. Personal Ringing

This feature allows two or three directory numbers to be assigned to the same line. This allows the subscriber to receive calls on up to three separate numbers without installing additional lines. A distinctive ringing pattern is provided for each directory number, so that the subscriber can identify the number that has been dialed.

G. Restricted Line Service with PIN

This feature provides the same abilities and restrictions as Restricted Line Service (Section 13.11.1), plus the ability to dial an authorization code and override the toll restriction on a per call basis.

When the Company assigns this feature to a line, a default PIN (Personal Identification Number) will be entered automatically. The subscriber will change to their PIN through the use of a PIN Change Access Code. Since the security of the PIN is under the customer's control, the customer will remain responsible for all toll calls made from their line.

H. Remote Activation of Call Forwarding

This feature allows a subscriber to activate, change or deactivate call forwarding service from any line capable of touch call signalling rather than only the base station line.

13.7.2 Description (Con't)

Feature Activation/Deactivation: The subscriber calls a Remote Access Directory Number and inputs his/her own directory number followed by a security code and then follows the appropriate Call Forwarding procedure to activate/deactivate a Call Forwarding feature.

Remote Activation of Call Forwarding is available only as an enhancement to Call Forwarding.
