**NOTICE OF INTENT TO REQUEST  
CONFIDENTIAL CLASSIFICATION**

Florida Power Corporation ("FPC") by and through undersigned counsel, pursuant to Rule 25-22.006, Florida Administrative Code, hereby files this Notice of Intent to Request Confidential Classification of portions of the enclosed tables which are to be appended to Exhibit "B" of FPC's Petition for Expedited Approval of Settlement Agreement between FPC and Orlando Cogen Limited, L.P. ("OCL") and its related parties, Air Products and Chemicals, Inc. ("Air Products") and UtilCo Group, Inc. ("UtilCo"), filed by Florida Power Corporation on February 19, 1996. Due to concerns over pending settlement negotiations between FPC and other cogenerators, which settlement negotiations might be unfavorably influenced to the detriment of the ratepayers by the publication of the information in the table, FPC hereby files the following in support of this Notice:






