CASE BACKGROUND

Section 364.337(3), Florida Statutes, reads as follows:

(3) The commission shall grant a certificate of authority to provide intrastate interexchange telecommunications service upon a showing that the applicant has sufficient technical, financial, and managerial capability to provide such service in the geographic area proposed to be served.

ISSUE 1: Should the Commission grant ANCHOR COMMUNICATIONS CORPORATION (ACC) a certificate to provide statewide interexchange telecommunications service within the State of Florida as provided by Section 364.337 (3), Florida Statutes?

ACC's exhibit of managerial qualifications (page 3) reflects a satisfactory record in telecommunications sales, marketing and In regard to technical capability, ACC indicates in its application that it will be a switchless reseller and will rely on the network ownership, operation and management of its underlying carrier(s) such as MCI, AT&T, etc. The Division of Auditing and Financial Analysis reviewed ACC's financial statement to determine the company's financial viability (pages 4-5). Based on the information provided by ACC, the financial capability of the company appears marginal. ISSUE 2: Should this docket be closed? RECOMMENDATION: Yes, if no person whose substantial interests are affected by the Commission's Proposed Agency Action files a protest within 21 days of the issuance date of the order. STAFF ANALYSIS: This docket should be closed if no person whose substantial interests are affected by the Commission's Proposed Agency Action files a protest within 21 days of the issuance date of the order.

He was President of Cell Connection from November 1993 until May of 1995. He also served as President of Florida One Capital Corporation from December 1987 through November 1993. Mr. Lewis was Vice President of Marketing and Communications for the Howze Group from October 1981 until November 1987. Responsibilities with the Howze Group included designing systems for government agencies within the state of Florida. He also held the position of President of James J. Lewis Consulting, Inc. from February 1975 until September 1981.

John J. Edwards, Jr.

Mr. Edwards is currently serving as special assistant to and consultant for the CEO of Anchor Communications, Corporation. He was Vice President for National Communication Auditors Association. He also served as Vice President of Marketing for Cell Connection. Mr. Edwards worked for AT&T in the Major Accounts Division as a manager and retired after 22yrs of service.

 - (4)(d) The Commission shall exercise its exclusive jurisdiction in order to: (d) Promote competition by encouraging new entrants into telecommunications markets

Regarding the showing of financial capability, the Finance staff has analyzed the unaudited balance sheet of Anchor Communications Corporation (Anchor). An audit could change one's opinion of the company's financial condition. The company has adequate liquidity and ownership equity but is beginning operation and does not have an income statement.

For certification purposes, the application appears marginal.
