It appears that your water and wastewater utility failed to timely file its 1992 Annual Report with this Commission.

Pursuant to Rule 25-30.110(3), Florida Administrative Code, the 1992 Annual Report was due on March 31, 1993. Our records indicate that you timely requested and were granted an extension through April 30, 1993 and that your Annual Report was received on June 29, 1993.

The Commission may impose fines for this noncompliance as provided for under Rule 25-30.110(6) and (7), Florida Administrative Code. Staff has determined that the applicable penalty for this Class "C" utility for 60 days x \$3.00 per day is \$180.00

Please submit payment of \$180.00 by check made payable to the Florida Public Service Commission.
