Issue 2: Recommendation that, if no person whose substantial interests are affected files a protest within 21 days of the issuance of the order, the order will become final. The provider will have 30 days from the date the Order becomes final to pay a \$250 fine and provide staff with the information as required by Rules 25-24.480(3)(a) and (b), F.A.C., or its certificate will be cancelled without further Commission action. The fines are to be paid to the Florida Public Service Commission and forwarded to the Office of Comptroller for deposit in the General Revenue Fund pursuant to 364.285(1), F.S. Upon payment of the fines or cancellation of the certificates, these dockets should be closed without further Commission action. A protest of one docket should not prevent the action in a separate docket from becoming final.
