

dinners. As we will be made to stop this practice sometime in the near future, suggestions were made as to how we will handle it. One was for a new set of dishes that would be lighter in weight than what we now have. Another was for each of us to bring our own place setting. Anyone having a suggestion on this issue, let us know by writing it on a slip of paper, and putting it in the FCCA mail slot.

We also discussed how we, the board, can serve the residents better. Joe Giarrusso suggested a questionnaire. During the month of September, each district board member visit homes in his or her district, in order that we get your input on such matters as what kind of FCCA meetings you want. If there are any activities we do not have that you would like, etc., the FCCA is your voice, so we want to hear your opinions.

After receiving many complaints in regard to the late charge on water bills, I contacted Orange Country Water District as to rates etc. learned that due to Fairways getting one bill for the whole park, we pay the rate of \$1.65 a thousand for water and \$2.83 for sewer, for a total of \$4.48. The reason our bills are so high is that we pay on a pro rated basis for every gallon we use over the 3,000 gallons which is included in our rent. Believe it or not, it is still costing us less than if we were direct customers of Orange County, as they have a zero rate of \$20.09, and it goes up from there. Example: 4,000 gallons costs us \$4.48. If you were billed by Orange County, it would cost you \$32.51. As to the late charge, management is refunding the \$10.00 charge on any bills that were paid by the 5th of the month, and have extended the grace period by five days.

Bring it to our office as you may have already been scheduled for discontinuance of service for non-payment.

DEPOSITS -

All residential deposits collected will be held until the customer has paid twelve (12) consecutive monthly bills and has not had an involuntary turn-off, a dishonored check charge, or more than two (2) delinquent notices. Commercial deposits will be held for the duration of the account. Deposits accrue six percent (6%) interest annually which will be paid when the deposit is refunded. Interest will not, however, be paid on deposits held for less than six (6) months. If the deposit is still being held when the account is terminated, the deposit and accrued interest, if any, will be applied to the account on the final bill and any resulting credit will be refunded.

DISCONTINUANCE OF SERVICE FOR NONPAYMENT -

Customers who have not paid their utility bill by the due date shall be liable to have their service discontinued. Prior to restoration of service, all charges currently owed must be paid. The amount owed shall include any applicable deposits, turn-off charges, turn-on charges, and charges for any services rendered or billed to the customer at the time of proposed reinstatement. A penalty of \$1,000 will be charged for unauthorized connections.

TEMPORARY TURN-OFF OF SERVICE -

If you plan to be away from your residence for an extended period and you do not have a need for water service, you may wish to consider requesting a temporary turn-off of service. During the period in which the temporary turn-off is in effect, monthly billings will not be rendered. There is, however, a one-time charge for each request which is billed at the time the request is made. This charge covers both the turn-off and turn-on of service if requested during normal office hours.

TERMINATION OF SERVICE -

In order to terminate service, you must notify our office either in writing or by telephone of your intent to do so. At that time, it will be necessary for you to provide us with a forwarding address to which your final bill or refund (if applicable) is to be mailed.


As you are aware, your Rental Agreement provides that the cost of your first 3,000 gallons of water usage each month is included in your base rent. Although the Rental Agreement gives Fairways the right to bill you for water usage in excess of 3,000 gallons per month, until now it has been Fairways' practice not to bill you for such usage. Recently, however, water usage has increased substantially on the part of some residents.

Because of this increased usage, beginning July 1, 1986, Fairways will begin billing residents for water and sewer usage in excess of 3,000 gallons per month. Your meter will be read monthly and you will be charged at the prevailing county rate. You will only be charged for usage in excess of 3,000 gallons each month. Should your water use exceed 3,000 gallons per month, you will begin receiving water bills on a quarterly basis.

Tidbits he Water



This article is intended to help the residents of Fairways understand how they are using their water and why some families use more than others:

Life style has something to do with it and excessive watering of the yard or flowers is one of the big things. Normal watering outside, during dry ... spells, will add some but not that much But, if you leave that garden hose run for 8 hours, you have just used up to 5,000 gallons of water!

With our water system you can use about 18 gallons per minute. That's 1,080 gallons per hour. That doesn't mean when you get a drink of water or turn a faucet on in the bathroom you use that much water but the water system to your home is capable of pro-

Here are some of the figures I got from "Orange Co. Public Utilities" on "! water usage. These are averages. SHOWER -25-50 gallons - 5-10 gals.per minute.

TUB - 36 gallons.

TOILET - 5-7 gallons per flush. DISHWASHER - 20 gallons.

WASHING MACHINE - 3-60 gallons.

BRUSHING TEETH - 2 gallons - (with water running).


HAND WASHING - 2 gallons - (with water running).

DISHWASHING - 20 gallons - (with water running) .

SHAVING - 3-5 gallons - (with water running).



We are allowed 3,000 gallons per month free from Fairways. Anything over that we will be charged for. The billing, as it stands now, will be every three months. I started offically reading water meters in July so our first bill will be last of October or the first part of November. The charge will be .98¢ for water; \$1.91 for sewage, for a total of \$2.89 per 1,000 gallons, or portion of, over the first 200 -- 11--

Since I started reading meters in July, I must have found 40 or 50 leaks of various kinds. These are the thing that really make that water meter spir The ones that really surprised me were the leaky toilets, leaking black flapper, faulty flush-o-matic, water running over the overflow. These lear alone can add 10,000 gallons or more per month to your water usage. A lead faucet, 2000 gallons per month. It wouldn't hurt to check on these things once in awhile.

Remember, when we have company for a week or two, you can add another 1,0 gallons. More showers, etc.


.___ The normal water usage for two, per home in the park seems to be around 5,000 gallons per month. I try to kees an eye on what you use. Some other tidbits. People with built-in sprinkler systems or garden hoses on timers will use more water. Working families use more water. Peop with kidney problems or taking water pills will use more water.

I hope this article will help you understand why you used the water you did when you get your bill. Don't blame it on a bad water meter. I've checked 40 or so and the ones that were had didn't register at all








A lot more water comes out of a faucet than we realize. These drawings show how much does come out of a faucel. A tiny drip adds up to 15 gallons a day.

A small stream adds up to 25 gallons.


And if a half-inch faucet were left open all day it would use up 6,400 gations.

A small lesk can make the water bill go up quite a bit, If not repaired.




4 stream 1/16 of an inch

Loses 100 gallons a day.




A stream 1/8 of an Inch Loses 400 gallons a day.
