FLORIDA STEEL CORPORATION'S NOTICE OF WITHDRAWAL OF MOTIONS TO STRIKE

Florida Steel Corporation, now known as AmeriSteel Corporation, hereby files this notice that it is withdrawing the Motion to Strike Florida Power & Light Company's Motion to Dismiss Florida Steel Corporation's Petition and Protest on Proposed Agency Action to Approve a Territorial Agreement and the Motion to Strike Jacksonville Electric Authority's Motion to Dismiss Florida Steel Corporation's Petition and Protest on Proposed Agency Action to Approve a Territorial Agreement, it previously filed based on the untimely filing of the two Motions. The original Case Assignment and Scheduling Report indicated that the response to any protest was due by March 20, 1996. AmeriSteel's Motions were based on this deadline as the two Motions to Dismiss were not filed until March 26, 1996. The Revised Case Assignment and Scheduling Report, which was supplied to AmeriSteel on April 12, 1996, indicates that the response to any protest was not due until April 1, 1996. The two Motions to Dismiss in question were filed prior to that date. In light of the new date for the filing of responses to the protest contained in the Revised Case Assignment and Scheduling Report, AmeriSteel withdraws its Motions to Strike these responses as untimely.
