



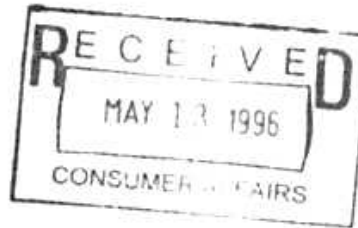


Dear Ruth Mchargus

Florida Power Corporation (FPC) and the City of Alachua have entered into an agreement which designates each utilities' retail service area. The agreement has been approved by both companies and is now before the Florida Public Service Commission (FPSC) for final approval. The FPSC has previously recognized that duplication of electric service facilities can create hazardous situations and result in higher costs to the customer.

This agreement which is the result of over a year of negotiations between FPC and the City will help both utilities serve existing and future customers in an economical and safe manner.

If the agreement is approved, your current electrical service location served by FPC will be located in the City of Alachua service area. Under the terms of the agreement your service location will be transferred to the City of Alachua system within six months after receiving final approval from the FPSC. You will not need to do anything to initiate this transfer since FPC and the City of Alachua will handle all of the arrangements on your behalf. Your deposit with FPC will be refunded directly to you, however, the City of Alachua may require a deposit equal to the one you currently have with FPC. Every reasonable effort will be made to minimize any inconvenience to you in regards to the transfer of service.

The following table represents the present residential and commercial monthly cost of electricity for the two utilities, and is provided for your information.


