Manatee County Declaring Manatee County Subject to the Provisions of Chapter 367. Florida Statutes - Request for non-turisdictional finding for provision of water

service by MIAMI VALLEY CONCRETE.

On October 10, 1995, the Board of County Commissioners of Manatee County adopted Resolution No. R-95-109, pursuant to Section 367.171, Florida Statutes, declaring that as of October 10, 1995, the water and wastewater utilities in that County shall become subject to the provisions of the Water and Wastewater Regulatory Law, Chapter 367, Florida Statutes. The resolution was acknowledged by this Commission on November 9. 1995, by Order No. PSC-95-1393-FOF-WS. Pursuant to Section 367.031, Florida Statutes, a utility subject to the jurisdiction of this Commission must obtain a certificate of authorization or an order recognizing the exempt status of the system.

On December 4, 1995, an application for a non-jurisdictional finding was filed on behalf of Miami Valley Concrete pursuant to Section 367.021(12), Florida Statutes. Miami Valley Concrete is a registered fictitious name for Miami Valley Ready Mix of Florida, Inc. The application was signed by Mr. James C. Brown as the President/Owner of the corporation. The primary contact for the application is Mr. James Twiggs. The mailing address for the system is P.O. Box 241, Ellenton, Florida 34222. The physical address of the system and mailing address for Mr. Twiggs is 3111 17th Street, East, Ellenton, Florida 34222 (941/723-1888). According to the application, this location is in Manatee County.
