REGARDING STREETLIGHT BILLING IN BROWARD COUNTY

On April 8, 1996, the Commission issued Proposed Agency Action Order No. PSC-96-0492-FOF-EU denying Broward County a refund from Florida Power and Light Company (FPL) for payments made for electric service to certain streetlight billings that the County claimed FPL billed improperly to the County. On April 29, 1996, the County timely filed a protest to the Commission's Proposed Agency Action.

Because there are two adversarial parties to this complaint, and because it is likely that the issues to be resolved will be mainly factual and will not involve controversial regulatory policy matters, this case may be appropriate for referral to the Division of Administrative Kearings.
