STIPULATION FOR AGENDA CONFERENCE

The Hobe Sound Water Company and the Town of Jupiter Island, (Motion to Intervene pending) file this stipulation for the agenda conference scheduled June 11, 1996 before the Florida Public Service Commission in the above styled limited rate proceeding, Docket No. 960912-WU and state;

1. The Staff for the Commission has issued its Memorandum and Recommendations to the Commission re this Docket dated May 30, 1996 (the "May 30 Memorandum").

2. Neither the Hobe Sound Water Company nor the Town of Jupiter Island fully agree with the contents and recommendations set forth in the May 30 Memorandum, each disagreeing with various portions of the May 30 Memorandum.

3. Despite both parties' respective objections to portions of the May 30 Memorandum, in the interest of the public and to avoid the unnecessary expense of a full blown hearing in this docket, the Hobe Sound Water Company and the Town of Jupiter Island agree to accept Staff's Recommendations set forth in the May 30 Memorandum as a reasonable compromise of each party's position, and accordingly neither party will contest such Recommendations, and neither party will protest any PAA order adopting such Recommendations, except as set forth in section 4 below.

4. In the event that any other proper party or a member of the Commission objects to Staff's Recommendations set forth in the May 30 Memorandum, or in the event that Staff changes its Recommendations in the May 30 Memorandum, or in the event that any other substantially affected person protests any FAA order adopting such Recommendations then the compromise set forth in section 3 above shall be void, and either party shall be free to pursue its respective disagreements with Staff's Recommendations. De minimis changes in Staff's Recommendations shall be excluded from the provisions of this section 4.

WHEREFORE, the Hobe Sound Water Company and the Town of Jupiter Island file this Stipulation with the Commission.


