#### CASE BACKGROUND

On May 29, 1996 St. Joseph Telephone and Telegraph Company (St. Joe or the Company) filed a proposed revision to its present tariff. The Company is proposing the addition of a new digital switched service, Switched 56 Service. Switched 56 Service is a digital switched service which will allow bulk information transfer, up to 56 kbps, via a specially equipped four wire access line.

#### DISCUSSION OF ISSUES

**ISSUE 1:** Should the Commission approve St. Joseph Telephone and Telegraph's tariff filing to introduce Switched 56 Service?

**RECOMMENDATION:** Yes. The Commission should approve St. Joseph Telephone and Telegraph's tariff filing to introduce Switched 56 Service.

**STAFF ANALYSIS:** Through its tariff filing, St. Joe seeks approval to introduce a digital switched service, Switched 56 Service. This new digital service will allow St. Joe to enhance its existing services.

Switched 56 Service is a digital switched service that provides full duplex (two way) data transport over a specially equipped four wire access line at speeds up to and including 56 kbps. The Company believes this service will be used to provide bulk data transfer, distributions, video teleconferencing, and other applications. The flexibility of Switched 56 Service will allow customers to communicate among a number of locations where it may not be cost effective to use private line services. Switched 56 Service is not voice functional.

Switched 56 Service is provided in conjunction with intraLata communications. InterLata communications are supported by the Access Service Tariff section E6. Switched 56 Service is an end-to-end digital information transport service that provides data signals in a manner which is similar to the way the message telecommunications service network provides circuit switched capability for voice frequency signals. Switched 56 Service is provided through DMS 10 or DMS 100/200 digital switches.

Technically, Switched 56 Service is a premises to premises switched data service which transports up to 56 kbps of data over a non-loaded local loop. The loop is non-loaded because it is an end-to-end digital service and loaded coils interfere with digital transmission. This service transmits data back and forth so fast that it is transparent to the end user. DOCKET NO. 960694-TL DATE: June 13, 1996

Switched 56 can be provided directly to customers within 18 kilofeet (18,000 feet) of the Switched 56 equipped central office. If customers are not within 18 kilofeet of an equipped central office, they must subscribe to Switched 56 Service Remote Capability. This service provides a specially equipped T-1 carrier from the subscriber central office to the switch where Switched 56 equipment is located. The special equipment is necessary to extend a Switched 56 Service Access Line to certain customers who are served by central offices other than a Switched 56 serving central office.

The rate structure for Switched 56 Service is largely usage based. (See attachment No. 1 - Tariff Pages 5 and 6 for the rates and charges.) The customer pays for the Switched 56 Service Arrangement, which refers to the equipment required per line to support the 56 kbps data transport. The customer then pays for the first minute and each additional minute. The company's MTS time of day discounts are applied, since this is a measured service, to both local and long distance calls. Also, if customers are not within 18 kilofeet of the Switched 56 equipped office they must pay for Switched 56 Remote Capability. The rates and charges proposed by St. Joe are identical to the rates charged by BellSouth for similar services.

Since no sales projections have been made, the revenue impact to the company is unknown. There is no customer impact, since there is no existing service which provides this capability.

The cost to the company consists of the purchase and installation of central office based equipment. Engineering and Programming costs are recouped with the nonrecurring charges. The estimated cost of the special equipment is \$350.00 and the nonrecurring charge is \$725.00.

In summation, Switched 56 Service appears to be a very viable service which provides the customer with a data transport system capable of transmitting information up to 56 kbps at rates identical to the rates charged by BellSouth for a similar service. Staff believes that the addition of Switched 56 Service will allow St. Joe to provide a digital switched service currently available to customers of other local exchange companies.

# ISSUE 2: Should this docket be closed?


