By this letter, TeleCommunication Systems, Inc. d/b/a TCS Network Services ("TCS") and Telecom One. Inc. ("TOI") hereby jointly inform the Florida Public Service Commission ("Commission") that TOI has acquired the Florida customer base of TCS. Both TCS and TOI are certified by the Commission. The Commission granted TCS a certificate to provide interexchange telecommunications service in Docket No. 950723-TI, Order No. PSC-95-1200-FOF-TI, on September 25, 1995. The Commission granted TOI a certificate to provide interexchange telecommunications service in Docket No. 931152-TI, Order No. PSC-94-0178-FOF-TI, on March 8, 1994.
