Dear Mr. Bayo:

On May 31, 1996, LCI International Telecom Corp. ("LCI Telecom") and Pennsylvania Alternative Communications, Inc. ("PACB") filed a letter with the Florida Public Service Commission ("Commission") notifying the Commission of their intention to transfer selected assets from PACB to LCI Telecom. This letter was assigned Docket No. 960682-TI. By letter dated June 12, 1996, LCI Telecom and PACB requested that the Commission cancel PACB's Certificate of Public Convenience and Necessity upon consummation of the transfer of assets, which they anticipate will be on June 28, 1996. PACB received its Certificate of Public Convenience and Necessity on February 12, 1993 in Docket No. 920974, Order No. PSC-93-0121-POP-11, Certificate No. 3146.

The assets to be transferred from PACB to LCI Telecom include: (1) all of PACB's retail long distance telecommunications services customer accounts; (2) all of PACB's rights with respect to its sales agents and sales agencies and all records, payment and other information related thereto; and (3) all dialer equipment and other assets necessary to provide service to PACB's dialer customers. PACB's Certificate of Public Convenience and Necessity will not be transferred as LCI Telecom has its own operating authority.


