**1.2 Definitions**

**Access Line** - An arrangement which connects the Subscriber's or Customer's location to the Carrier's designated point of presence or network switching center.

**Accounting Code** - A two- to seven-digit code which enables a Customer to identify individual calls for accounting purposes.

**Authorization Code** - A five- or seven-digit code which is used to identify individual Customers or groups of Customers, and thereby allocate the costs of their long distance service.

**Authorized User** - A person, firm or corporation, or any other entity authorized by the Customer to communicate utilizing the Company's services.

**Carrier or Company** - SUMMIT Teleservices, Inc., unless (T) otherwise indicated by the context.

**Customer** - The person, firm or corporation, or other entity which orders, cancels, amends, or uses service and is responsible for the payment of charges and/or compliance with tariff regulations.

**Customer Premises Equipment** - Terminal equipment, as defined herein, which is located on the Customer's premises.

**Day Rate Period** - From 8:00 AM to, but not including, 5:00 PM Monday through Friday.

**Evening** - From 5:00 PM to, but not including, 11:00 PM Sunday through Friday.

**Expedite** - A service order initiated at the request of the Customer, plus the accompanying installation or change charge that is processed in a time period shorter than the SUMMIT standard service interval quoted at the time of the order.

**Joint User** - A person, firm, corporation or other entity designated by the Customer as a user of communication facilities furnished to the Customer by SUMMIT, and to whom a portion of the charges for such facilities are billed under a joint user agreement as specified in this tariff.

**Holiday** - One of the following federally recognized holidays: New Year's Day (January 1), Independence Day (July 4), Labor Day, Thanksgiving Day, and Christmas Day (December 25).

**Night/Weekend** - From 11:00 PM all days and weekends beginning after 11:00 PM Friday to, but not including 5:00 PM Sunday.

**Special Access** - Where access between the Subscriber or Customer and the interexchange carrier is provided on dedicated circuits. The cost of Special Access is billed to the Customer by the local exchange carrier.

**SUMMIT** - Used throughout this tariff to refer to SUMMIT (T) Teleservices, Inc., unless otherwise clearly indicated by the context.
