Rate Schedule RSLE  
RESIDENTIAL LOAD ENHANCEMENT SALES SERVICE

Availability:

In all of the Company's service area.

Applicability:

To any residential customer, existing or new, which takes gas service and meets the conditions specified in this paragraph. An existing Customer which is served under either Rate Schedule RS or RACS must satisfy two conditions to be eligible for service under Rate Schedule RSLE on or after the Origination Date; (a) the Customer must add incremental gas consumption, as defined below, on or after the Origination Date, and (b) the portion of the incremental consumption taken during the April through October period must equal at least two (2) times the portion of the incremental consumption taken during the November through March period. For any person which was not a residential customer of the Company on the Origination Date, such person shall be deemed a new Customer for the purposes of this rate schedule and shall be eligible for RSLE service after the Origination Date if its total projected gas consumption during the April through October period is at least two (2) times its total projected gas consumption for the November through March period. The Company may review a Customer's actual consumption history at the end of each calendar year to determine if the Customer is eligible for RSLE for the next calendar year.

Character of Service:

Natural gas or its equivalent having a nominal heat content of nine hundred fifty (950) Btu per cubic foot.

The Company will, at all times, use reasonable diligence to provide continuous gas service, but shall not be liable to the customer for failure, curtailment or interruption of gas service due to Company's pipeline supplier(s) or any cause or act constituting Force Majeure as defined in the General Rules and Regulations of the Company.
