

Florida's Public Service Commission Approves Method By Which Incoming Calls At Pay Telephones May Be Blocked Upon Request Of Law Enforcement To Assist Crime Fighting Efforts

Under previous guidelines of the Florida Public Service Commission (PSC), most public pay phones were required to be capable of receiving calls. There were limited exceptions for some phones such as those located at correctional institutions, schools, and hospitals. Recognizing that certain pay phones were being utilized to facilitate the commission of crime, the PSC has revised its "incoming call blocking" rule to allow law enforcement to seek to block specific public pay phones from receiving incoming phone calls.

4.

Incoming calls can be blocked to prevent a public pay phone from being used to facilitate criminal activity.

Under the new guidelines, the PSC may specifically authorize exempting certain public phones from the "incoming call capable" requirement. The text of the revised rule allowing such exemptions requires a request to be made on PSC Form PSC/CMU-2 (12/94), a copy of which is found on the reverse side of this Bulletin. 1

A separate form must be submitted to the PSC for each pay phone for which incoming calls are to be blocked. The form has three sections, and must be executed by three parties: (1) The owner of the pay telephone company, indicating, among other things, agreement to post a notice on the phone stating. "Incoming calls blocked at request of law enforcement," (2) The owner of the location where the phone is located, indicating, among other things, a belief that blocking incoming calls will eliminate or help control criminal activity associated with and facilitated by incoming calls at the pay telephone; and (3) The Chief of the law enforcement agency of the jurisdiction where the phone is located, declaring that to the best of his/her knowledge and belief, criminal activity is associated with and facilitated by incoming calls being received at the phone and that blocking incoming calls will eliminate or help control criminal activity at the phone's location. All signed statements are subject to the misdemeanor penalty found at F.S. 837.06 for making a false statement in writing with the intent to mislead a public servant in the performance of his official duty.

The PSC reports that 150 public pay obones have already been approved for incoming call-blocking in the Miami/Ft. Landerdale area.

To utilize this new law enforcement tool, agency heads should have the PSC Form (see reverse side of this Bulletin) properly executed, and then submit it to PSC for consideration. For further assistance from the PSC, please contact Laura V. King at (904) 488-1280 (SunCom 278-1280).
