1. PCS is an Alternative Local Exchange Carrier ("ALEC") certified by the Florida Public Service Commission (Docket No. 960555-TX). PCS is soon to begin providing local exchange service on a resale basis in Florida.
2. PCS is also an Interexchange Carrier ("IXC") certified by the Florida Public Service Commission (Docket No. 951363-TI). PCS is also soon to begin providing interexchange service throughout Florida.
3. As an ALEC and IXC, BellSouth's compliance with the Section 271 checklist will directly impact PCS's ability to compete in the local and long distance telecommunications market in Florida.

For these reasons, PCS's interests will be substantially affected by the resolution of issues in this docket.




