SECOND AMENDATORY ORDER

BY THE COMMISSION:

On July 23, 1996, this Commission issued Order No. PSC-96-0897A-FOF-WS, amending Order No. PSC-96-0897-FOF-WS to reflect the incorporation of Attachment A describing the additional territory to be included in Certificate Nos. 533-W and 464-S held by Southlake Utilities, Inc. Attachment A had been inadvertently omitted from Order No. PSC-96-0897-FOF-WS. Subsequent to the issuance of Order No. PSC-96-0897A-FOF-WS, it was discovered that Attachment A contained a typographical error in the last paragraph of the legal description of the amended territory. Accordingly, the last paragraph of the legal description of the amended territory is amended as follows:

That part of Section 35, Township 24 South, Range 26 East, Lake County, Florida, lying west of US Highway No. 27. Less: the southwest quarter of the southwest quarter; the southwest quarter of the southeast quarter of the southwest quarter; the west half of the northwest quarter of the southeast quarter of the southwest quarter; the south half of the northwest quarter of the southwest quarter; the northwest quarter of the northwest quarter of the southwest quarter; the southwest quarter of the northeast quarter of the northwest quarter of the southwest quarter; the west half of the southwest quarter of the northwest quarter; the southwest quarter of the northwest quarter of the northwest quarter; less the south 60 feet of the southwest quarter of the southeast quarter of the southwest quarter. And also less: Beginning on the west side of US Highway 27, 60 feet north of the south line of the section; run west 230 feet, north 279.32 feet, east 152.02 feet, and southeast along the highway, 290 feet to the Point of Beginning. And also less: the south half of the northeast quarter of the southeast quarter west of the highway (less the north fifteen feet); the north 180.28 feet of the southeast quarter of the southeast quarter of the highway, less: beginning at the intersection of the west

right-of-way of US Highway 27 with the south line of the north 180.28 feet of the southeast quarter of the southeast quarter; run northwesterly along the highway 175 feet, west 145 feet, south 164.25 feet, east 205.38 feet to the Point of Beginning. And also less territory already served by Southlake Utilities, Inc.

Based on the foregoing, it is, therefore,

ORDERED by the Florida Public Service Commission that Order No. PSC-96-0897A-FOF-WS is hereby amended as set forth in the body of this Order. It is further

ORDERED that Order No. PSC-96-0897A-FOF-WS is reaffirmed in all other respects.
