PREFILED TESTIMONY: Testimony, exhibits and data relative to the issues above shall be prefiled as set forth in the Order Establishing Procedure issued in each docket.

PRACTICE AND PROCEDURE: All parties will be given an opportunity to be heard. These proceedings will be governed by the provisions of Chapter 120, Florida Statutes, as well as Chapters 25-6, 25-7, and 25-22, Florida Administrative Code.

JURISDICTION: Public Service Commission jurisdiction over the rates and charges of investor-owned utilities is established by the provisions of Sections 366.06 and 366.07, Florida Statutes. Jurisdiction to consider recovery of environmental costs is established by the provisions in Section 366.8255, Florida Statutes.
