

In our recent telephone conference, you requested additional information in connection with Homosassa Sewer Association, Inc.'s request for exemption from PSC regulation. The response to your inquiry are as follows:

1. Water Service to the customers of this Association is provided by Citrus County.

2. H2O Utility Services, Inc. will be handling the billing for the Association. Its address is 1518 U.S. Highway 19, Suite C, Holiday, Florida 34691 and its contact person is Mr. Gary Deremer, its President.

3. The service area presently consists of the Springs Plaza Shopping Center, including the Island Stores and Hardees out parcels then proceeding approximately one mile north to the Homosassa Industrial Park and the adjacent property on the south. A map generally showing these areas is enclosed.

4. The Special Warranty Deed conveying the plant and pond sites to the Association has been forwarded to the current owner for execution. The person whose signature is required on this Deed is not immediately available and we expect to have that document signed next week and I will forward you a copy.

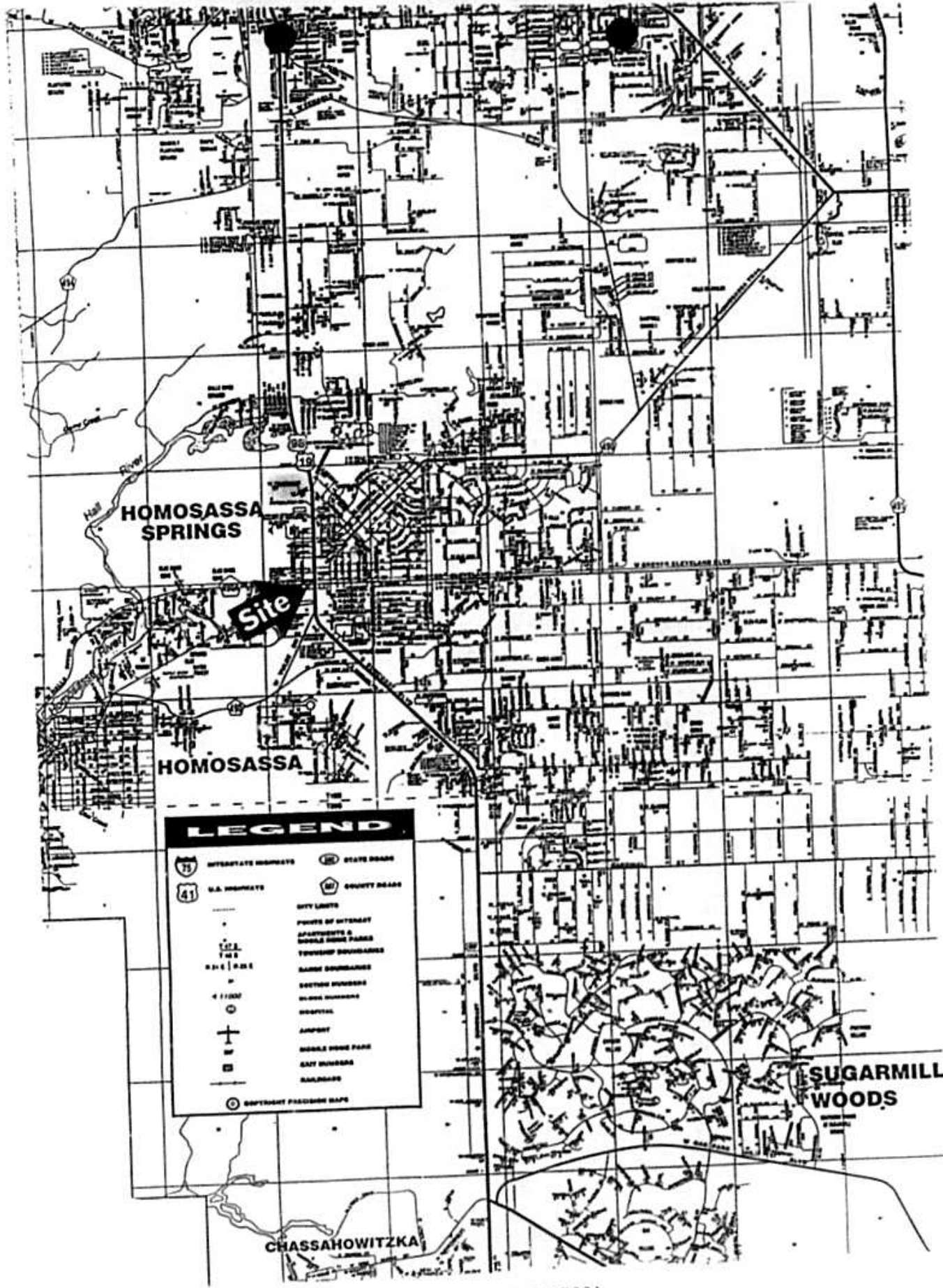
