ISSUE 1: Should Mr. Donald Brandt be named to the Advisory Committee?

RECOMMENDATION: Yes.

STAFF ANALYSIS: TASA allows the Advisory Committee to consist of up to ten members recommended by various organizations and named to the committee by the Commission. Mr. Steve Bail, the incumbent nominee for The Deaf Service Center Association (DSCA), has resigned from that position. Mr. Brandt is the new DSCA nominee and will fill the open position created by Mr. Bail's departure. Mr. Brandt is the Vice President of DSCA.

On July 30, 1996, Ron Ospatich, President/DSCA, responded to staff's inquiry regarding compliance with section 427.706(1) of the TASA law which addresses the necessary characteristics and qualifications one must have to become an Advisory Committee member (Attachment A). TASA requires the DSCA nominee be "one person with experience in providing relay service." Mr. Brandt meets the requirement. Staff recommends that Mr. Brandt be named to the Advisory Committee.
