MOTION FOR EXTENSION OF TIME

COMES NOW BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Motion for Extension of Time, and states as grounds in support thereof the following:

1. On August 12, 1996, BellSouth filed its Amended Notice of Intent to Request Confidential Classification concerning proprietary information of BellSouth that was attached to AT&T's Petition for Arbitration. The hearing in this docket is not scheduled until October 9-11, 1996. The Request for Confidential Classification is due on Tuesday, September 3, 1996.

2. Because of the voluminous nature of the documents that are the subject of the Notice of Intent, the fact that the personnel needed to assist in the preparation of the Request for Confidential Classification are also required in other dockets, and the fact that no party will be prejudiced, BellSouth respectfully requests that the deadline for filing its Request for Confidential Classification be extended until September 10, 1996.

WHEREFORE, BellSouth respectfully urges the Commission to extend the filing deadline for BellSouth's Request for
