WITHDRAWAL OF NOTICE OF INTENT

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), files this Withdrawal of their Notice of Intent to Request Specified Confidential Classification originally filed on September 3, 1996.

1. On September 3, 1996, the Joint Complainants (FIXCA, MCI, AT&T, etc.) advised BellSouth that the Joint Complainants would be filing testimony with the Commission containing information considered to be confidential and proprietary to BellSouth in the above captioned docket. The proprietary information, according to the Joint Complainants, is located in the Exhibits and the Testimony of Sandra Seay. BellSouth filed a Notice of Intent to protect this information on September 3, 1996.

2. The material contained in the documents that BellSouth produced that was initially determined by BellSouth to be confidential and proprietary business information was reviewed in connection with the filing of the Request for Confidential Classification. It was determined that this specific information
