These documents support GTEFL's cost study, which has already been filed with the Staff (and given to AT&T and MCI under a protective agreement) as part of GTEFL's response to the respective arbitration petitions of AT&T and MCI. The binders filed today include all the information submitted in the earlier, one-binder filing, but with the addition of vendor-specific material. GTEFL is submitting this information again in conjunction with the new material so that Staff can more easily determine where the new material fits within the cost study originally filed. Staff can discern which material is new because it is stamped "Highly Sensitive Confidential Information." The other, previously submitted documents are also confidential, but they are stamped "Confidential Information." For Staff's convenience, GTEFL has attached a cross-reference guide that shows the page numbers in the originally submitted cost study binder that correspond to the page numbers in the supplemental binders filed today.

In addition, this cover letter serves as GTEFL's notice, pursuant to Commission Rule 25-22.006(5), that GTEFL is claiming confidential treatment for all of GTEFL's cost study materials submitted with this letter. GTEFL plans to introduce these cost study materials into evidence. Therefore, I understand that the Company will need to file a request for permanent confidential classification 21 days after the close of the hearing, as provided by Commission Rule 25-22.006(8)(b).
