COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. On October 4, 1996, BellSouth filed Total Element Long Run Incremental Cost Studies for the 2-wire analog voice grade loop, the 4-wire analog voice grade loop, and the 2-wire ISDN digital grade loop.

2. The information contained in these cost studies is proprietary. This information is clearly confidential and proprietary under Florida Statutes, Section 364.183 and Rule 25-22.006, Florida Administrative Code.
