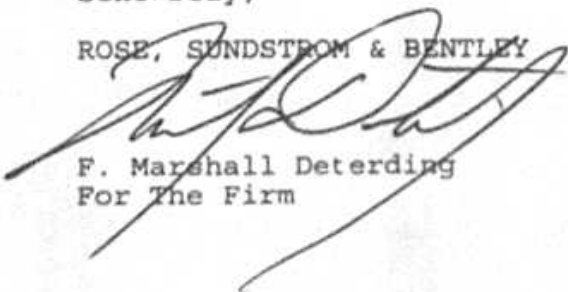
Dear Paulette:
