# ARTICLES OF INCORPORATION OF G & H TELECOM, INC.

#### ARTICLE I - NAME

The name of this corporation is G & H TELECOM, INC.

#### ARTICLE II - DURATION

This corporation shall exist perpetually.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock.

# ARTICLE V - SHAREHOLDER PREEMPTIVE RIGHTS
