Tampa Electric Company ("Tampa Electric" or "the company") hereby withdraws its requests for specified confidential treatment as they relate to the following:

- 1. On March 8, 1996 Tampa Electric filed its request for specified confidential treatment of Tampa Electric's Answer to Interrogatory No. 17 of Staff's Second Set of Interrogatories. This answer to Staff's Interrogatory No. 17 was not submitted into evidence and has been returned by the Commission to counsel for Tampa Electric.
- 2. On April 17, 1996 Tampa Electric filed its request for specified confidential treatment in response to Staff's First Request for Production of Documents in which Staff requested a copy of the Sulfuric Acid Sale and Purchase Agreement entered into on January 7, 1994 between Tampa Electric Company and Sulfuric Acid Trading Company. This response to Staff's First Request for Production was not submitted into evidence and has been returned by the Commission to counsel for Tampa Electric.

WHEREFORE, Tampa Electric Company withdraws the above referenced requests for specified confidential treatment.
