I have been asked to respond to an inquiry of May 2, 1995 regarding the exemption of Charlotte Bay Resort from your jurisdicton.

The letter says that you have been advised that we are a water and wastewater provider. Your adviser is in error. We do not provide water to our time share resort. Water is provided by the Charlotte Harbor Water Association. We do provide waste water disposal. The disposal plan! is licensed by the Florida Department of Environmental Protection, permit #FLA014073-278437.

Under Florida Statute 509.242 Public lodging establishments; clasifications, we are classified as a Resort Condominium (1)(c). We are licensed by the Department of Business and Professional Regulation. License #'s 18 00011C-08 & 18 00012C-08. Copy enclosed.

I believe, by statute, we are a public lodging establishment, with a private waste water disposal plant, licensed by the state and operated by state licensed contractors.
