## MOTION IN OPPOSITION TO PETITION FOR LEAVE TO INTERVENE

ATN, Inc., ("ATN"), pursuant to Commission Rule 25-22.037(2). Florida Administrative Code, hereby requests the Commission to deny Quincy Telephone Company's petition requesting the Commission grant it leave to intervene in these proceedings. In support of its Motion, ATN states:

- ATN Inc., is a Georgia corporation, duly authorized to do business in the state of Florida under the name AmTel Network, Inc., pursuant to authority granted by this Commission.

3. On May 13, 1996, ATN filed a Petition for Waiver of Rule 25-24.515(7). Florida Administrative Code (F.A.C.), and Rule 25-24.620(2) (c) and (d), F.A.C. By Order No. PSC-96-1062-FOF-TC issued August 20, 1996, the Commission granted ATN's petition. The order made provision for any person whose substantial interests are affected by the proposed action to file for a formal proceeding as provided by Rule 25-22.029(4) F.A.C., and in the form provided by Rule 25-22.036(7) (a) and (f), F.A.C. The order clearly stated that any such protest was to be received by the Director, Division of Records and Reporting, by the close of business on September 10, 1996.

- 4. Additionally, the above noted Commission Order, states at page 4, "that a protest filed by a local exchange company shall only be applicable to that local exchange company's territory and shall not prevent ATN, Inc. from handling this traffic in the territory of a local exchange company that does not protest this Order."
- ALLTEL Florida, Inc., was the only local exchange company to file a timely petition in response to the Commission's Order within the specified protest period.
- 6. The petitioner, Quincy Telephone Company, <u>failed</u> to file a timely petition for a formal proceeding, as provided by Rule 25-22.029(4) F.A.C. and now requests the Commission grant it relief by allowing it to intervene in these proceedings. The relief sought by the Qunicy Telephone Company would reward Quincy Telephone Company for failure to file its protest in a timely manner as provided by the rules, and effectively negate the provision of the order allowing ATN, Inc., to handle traffic in the territory of a local exchange company that did not timely protest the Order.
- 7. Further, granting the Quincy Telephone Company's petition to intervene would send the message that any local exchange company, failing to file within the specified protest period and thereby having abandoned its claims, was now free to intervene and re-establish interest in the proceeding based solely on the protest properly filed by ALLTEL of Florida, Inc. Such action would substantially harm ATN, Inc. in the lawful conduct of business in the territories of non-protesting local exchange companies and would be contrary to the Commission's rules and established procedures.

WHEREFORE, ATN respectfully requests that the petition for leave to intervene by the Quincy Telephone Company be denied. Respectfully submitted, this 23rd day of October 1996.
