As we discussed today, this firm represents the interests of Payphone Consultants, Inc. and The Other Phone Company, Inc.

Payphone Consultants, Inc. currently has a certificate to provide interexchange telecommunications service which was Docket No. 951233-TI, Order No. PSC-1544-FOF-TI, Issued December 15, 1995 and a certificate to provide alternative local exchange telecommunications service which was docket 950878-TX, Order No. PSC 95-1562, FOF-TX, Issued December 15, 1995. This corporation also holds other certificates relating to payphones.

Payphone Consultants, Inc. has a sole Director, Officer, and shareholder, John Murray, III. Mr. Murray has recently formed a second corporation, The Other Phone Company, Inc. of which he is again the sole Director, Officer, and shareholder.
