STATEMENT OF GULF POWER COMPANY REGARDING ISSUES AND POSITIONS

Gulf Power Company, ("Gulf Power", "Gulf", or "the "Company"), by and through its undersigned attorneys, files this statement of issues and positions, saying:

ISSUE 91: Should an electric utility be permitted to include, for retail fuel cost recovery purposes, fuel costs of generation at any of its units which exceed, on a cents-per-kilowatt-hour basis, the average fuel costs of total generation (wholesale plus retail) out of those same units?

GULF: Yes. The Commission should follow a policy which looks at the total net benefits to the retail customer with regard to off-system sales. This policy permits utilities to continue making off-system sales which benefit the retail customers.
