Southern States Utilities, Inc. (Southern States or utility) provides water and wastewater service to approximately 83,286 water customers and 43,527 wastewater customers in 28 counties in Florida. The utility's 1995 annual report shows an annual operating revenue of \$52,077,478 and a net operating income of \$2,356,915. The utility is a Class A utility company under FPSC jurisdiction.

On September 16, 1996 the utility applied for an quick take amendment to Water Certificate No. 189-W in Citrus County, Florida pursuant to Rule 25-30.036(2) and (3), Florida Administrative Code. The application is in compliance with the governing statute, Section 367.045, Florida Statutes, and other pertinent statutes and administrative rules concerning an application for amendment of certificate. The application contains a check in the amount of \$100 which is the correct filing fee pursuant to Rule 25-30.020, Florida Administrative Code. The applicant has provided evidence that the utility owns the land upon which the utility's facilities are located as required by Rule 25-30.036(3)(d), Florida Administrative Code.

APP Adequate service territory and a territory description in the provided as prescribed by Rule 25-30.036(3)(e), and (I), Florida Administrative Code. A description of the territory requested by the utility is appended to this memorandum as Attachment A. Attachment B includes a rewrite of the utility's Adequate service territory and a territory description have CMU ____ Crystal River Highlands water service area. The territory in the rewritten description is slightly different than the territory granted to the utility. Listed below is a summary of the explanation by Southern States' engineer Mr. Charles M. Bliss,

Manager of the Facilities Analysis Department.

We have reviewed your concern about the difference between the existing description indicating the existing territory to be the "North 750 feet of the Southeast quarter 'of the Northwest quarter of said Section 15" and the utility's proposed territory description indicating this distance to be

724.94 feet. This difference appears to be the result of differences between the recorded plat and the hand drawn Citrus County Property Appraisers map, but the intent of the two descriptions is the same in this part of the service territory, that is to include the lots associated with the Crystal River Highlands plat (Blocks A-F 64 lots), the road right of ways of Longfellow Drive, Sandburg Lane, Whitier Lane and West Kipling Lane and the five parcels of land fronting along U.S. Highway 19 on the Western side of the service territory.

The 750 feet distance was the result of information obtained from hand drawn Citrus County Property Appraisers maps obtained from Citrus County indicating the distance on the East boundary of Crystal River Highlands to be 730.34 feet plus 20 feet. The 727.94 feet is based upon the actual platted dimensions from the Crystal River Highlands plat. The plat also agrees with the Citrus County Property Appraisers map. It appears that the additional 20 feet referenced on the Property Appraisers map referenced the wrong corner points. This is confirmed by the actual northern boundary of the Crystal River Highlands plat being the north line of the Southeast quarter of the Northwest quarter and not as indicated in the Citrus County Property Appraisers map where the northern line Lots 2 through 10 of Block A are indicated to extend beyond the north line of the Southeast quarter of the Northwest quarter of the Northwest quarter of the Northwest quarter of the Northwest quarter of

Staff agrees with the utility's analysis, thus the composite revised description is approximately 20 feet less on one southern boundary. This of course has no effect on the customers the utility is currently serving.

The utility has submitted an affidavit consistent with Section 367.045(2)(d), Florida Statutes, that it has tariffs and annual reports on file with the Commission. In addition, the application contains proof of compliance with the noticing provisions set forth in Rule 25-30.030, Florida Administrative Code. No objections to the application have been received and the time for such has expired. The local planning agency was provided notice of the application and did not file a protest to the amendment.

The customer's well failed due to iron contamination, and his elderly mother, along with four other tenants on the property, are currently out of potable water. To serve this customers the utility will extended the water lines of the present system. The

DOCKET NO. 961110-WU DATE: November 18, 1996 Department of Environmental Regulation has no outstanding notices of violation issued for this system. The utility has filed revised tariff sheets incorporating the additional territory into its tariff and returned its certificate for entry reflecting the additional territory. The rates and charges contained in the utility's tariff on file with the Commission should be applied to service in the additional territory. In accordance with this rule, a request for service expansion shall be considered approved if no protest is timely filed to the application. As stated earlier, no protests have been filed and the time for such has expired. Based on the above information, staff believes it is in the public interest to acknowledge the application of Southern States for amendment of Water Certificate No. 189-W. An administrative order should be issued acknowledging the application, within 30 days. If you have any questions, please contact me.
