PETITION FOR APPROVAL OF FUEL COST RECOVERY
TRUE-UP FOR PERIOD ENDING SEPTEMBER 1996

Florida Power & Light Company ("FPL") hereby Petitions this Commission for approval of FPL's final Fuel and Purchased Power Cost Recovery Factor ("Fuel Factor") true-up amount of \$13,513,839 underrecovery for the April 1996 - September 1996 period. In support of this Petition, FPL states as follows:

1. The final \$13,513,839 Fuel Cost underrecovery for the period April 1996 - September 1996 was calculated in accordance with the methodology set forth in Schedule 1, page 2 of 2, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony of FPL witness R. Morley, which is being filed together with the Petition and incorporated herein.

2. The Commission approved a levelized Fuel Cost and Purchased Power Adjustment Factor of 2.204 cents/kwh for the period beginning October 1996 through March 1997. This Fuel Factor was based upon an "estimated/actual" underrecovery including interest for the period April 1996 through September 1996 of \$149,035,547. The actual underrecovery including interest for the period April 1996 through September 1996 is \$162,549,386.

underrecovery less the "estimated/actual" underrecovery of \$149,035,547, results in the final underrecovery of \$13,513,839. This final underrecovery of \$13,513,839 is to be included in the calculation of the Fuel Factor for the period beginning April 1997.

WHEREFORE, Florida Power & Light Company respectfully requests the Commission to approve the net \$13,513,839 fuel cost underrecovery as the true-up amount for the period ending September 1996, and include this amount in the calculation of the Fuel Factor for the period beginning April 1997.
