D) DOCKET NO. 961209-TI - Request for acknowledgement of transfer of assets from Comstco Corporation d/b/a Communications Network Corporation, holder of Interexchange Telecommunications Certificate No. 3974, to WorldCom Network Services, Inc. d/b/a WilTel Network Services, Inc., holder of Interexchange Telecommunications Certificate No. 552.

E) DOCKET NO. 961214-TI - Request for acknowledgement of transfer of stock from Intellicall Operator Services, Inc. to ILD, Inc.

F) DOCKET NO. 961204-GU - Application of Florida Division of Chesapeake Utilities Corporation to issue up to 4,866,909 shares of common stock and \$60,000,000 of secured and/or unsecured debt and to exceed the limitation placed on short-term borrowings by Section 366.04, F.S., so as to issue short-term obligations in an amount not to exceed \$40,000,000 during the year ending December 31, 1997.
