| 15 | Back in 1992 we contracted with MCI with a |
| 16 | five-year contract which will expire this coming May |
| 17 | 31st. As a result of that, in order to anticipate |
| 18 | that upcoming end of that contract, we issued an RFP |
| 19 | back in August. That RFP resulted in proposals that |
| 20 | were evaluated by an evaluation team of three |
| 21 | Commission Staff members and two of our advisory |
| 22 | committee members. The results of that evaluation, as |
| 23 | well as the price bids are contained in the |
| 24 | recommendation. And based on that process the bidder |
| 25 | with the highest number of points was MCI, and we're |

here today to recommend to you that we recontract with
MCI for a three-year period to provide relay service
beginning June 1 of 1997. We'd be glad to answer any
questions.

CHAIRMAN CLARK: Questions, Commissioners? 5 COMNISSIONER GARCIA: I just wanted to point 6 7 out for the record that I believe that -- importantly for me, even though I lost on the vote, is that we 8 kept the jobs in Florida, which I'm very pleased with, 9 and the fact is that the new contract produces 10 \$1.4 million in savings potentially.
