AGAINST FLORIDA POWER & LIGHT COMPANY CONCERNING BILLING
FOR ELECTRIC USE AT CUSTOMER'S RENTAL PROPERTY.

Mr. Eddy Grosse filed a complaint with the Public Service Commission's Division of Consumer Affairs (CAF). Mr. Grosse objected to Florida Power & Light Company, (FPL), a public utility, transferring unpaid balances from FPL accounts at rental properties he owns to his residential account. On August 5, 1996, the Florida Public Service Commission issued Order No. PSC-96-0998-FOF-EI, Notice of Proposed Agency Action Order Affirming Liability For Unpaid Balance. On August 26, 1996, Mr. Grosse faxed a letter protesting the Commission's Order. On October 29, 1996, the Commission found Mr. Grosse's protest to be timely filed.

Based on the foregoing, staff recommends that this matter be set for hearing. The issues will be primarily factual; thus this case may be appropriate for referral to DOAH.
