

On November 5, 1996, the Commission issued Proposed Agency Action Order No. PSC-96-1333-FOF-EI approving Florida Power & Light Company's backbilling Mr. Francisco Mesa for electric usage not previously billed. On November 26, 1996, Mr. Francisco Meso timely filed a protest to the Commission's Proposed Agency Action.

Because there are two adverserial parties to this complaint, and because it is likely that the issues to be resolved will be mainly factual and will not involve controversial regulatory policy matters, this case may be appropriate for referral to the Division of Administrative Hearings.
